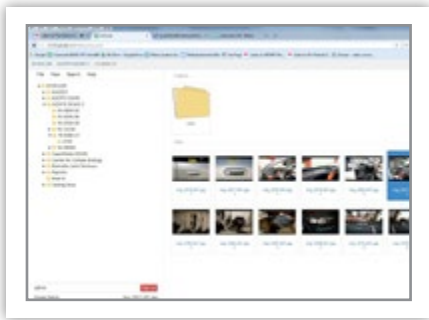
### Client Based Functionality

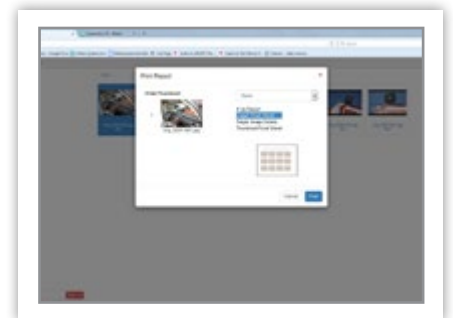


## Objective and Efficiencies

Users have access to reports and printing based on their CaseWorks<sup>DEMS</sup> credentials. Any report available to a user in client/server mode is also available via the web interface.

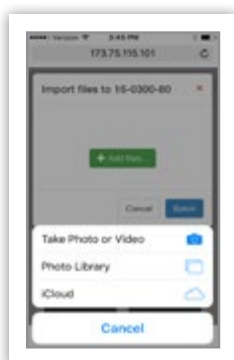
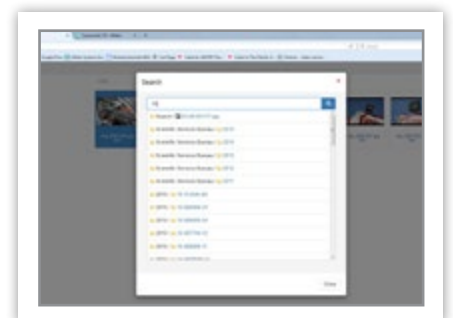


## Multi-Media Upload and View
